

Dr. W. A. Baker, Vice President for Academic Affairs, and Mr. Zack Prince, Registrar and Director of Admissions, have reviewed this resolution. In scheduling examinations for MWF and TTh classes, every effort is made for the final to be on the same day of the week that the class meets. Also, finals for evening classes are scheduled after 5 p.m.

There is a problem relating to departmental finals since these classes are scheduled at different hours during different days. To the extent possible, departmental examinations are scheduled in the 5:30 to 8:00 slot, but only four such slots are available without forcing 5:30 classes into another time slot. To avoid conflicts, six slots are needed for departmental finals, and thus two are scheduled outside the 5:30 to 8:00 slot. Every effort is made to schedule the other departmental finals during a time period that is convenient.

We certainly agree with the intent of this resolution and have tried to follow the procedure outlined whenever possible.

WHEREAS: Dr. Wendell Nedderman has served as the President of the University of Texas at Arlington the past 19 years;

WHEREAS: During his Presidential tenure, undergraduate enrollment has increased from 13,500 in 1972 to 24,800 in 1990 and graduate enrollment has increased from 936 to over 4,000;

WHEREAS: 20 Baccalaureate, 23 Masters, and 17 Doctoral degree titles have been added during this period;

WHEREAS: A School of Architecture, a School of Nursing, and a Center for Professional Teacher Education have been added during this period;

WHEREAS: There are some 20 new building (or major additions to buildings) totaling some 1,600,000 gross sq. ft. of new space;

WHEREAS: Dr. Nedderman served as the first UTA Dean of Engineering from 1959-1969, Graduate School Administrator from 1967-1969, Vice-president for Academic Affairs from 1968-1972, and President and Professor of Civil Engineering from 1972-present;

WHEREAS: Dr. Nedderman has maintained a working relationship with and a strong interest in the Student Community and Student Congress;

WHEREAS: Dr. Nedderman has contributed immeasurably to the strong academic reputation of UTA;

WHEREAS: A successor will soon be found for the retiring University President;

BE IT THEREFORE RESOLVED THAT: Student Congress officially express our appreciation by inviting Dr. Nedderman to the next general meeting and present him with an honorary Student Congress T-Shirt.
