I have been contacted by Clayton Starkweather regarding Resolution 92-~~30~~. I understand that the reason for this particular resolution is to enable student attendance at Student Congress meetings as well as Arlington City Council meetings.

It is my opinion that government is best realized and most representative when it is participated in by the majority of the people. Municipal government is most easily identified as government "of the people, by the people, and for the people," for it is at the city level where the responsiveness of elected officials to their constituency is readily weighed and measured.
