Subject: Student Congress Resolution 92-27

Although I am sympathetic with the problems that some student organizations have in struggling to provide services to their members, I recommend that we not approve Student Congress Resolution 92-27. My reasons are as follows:

1. We currently provide program assistance money to student organizations through Student Governance and Organizations. Approximately \$6,000 is budgeted for 1992-93. This fund could be increased as our financial situation improves. The existence of this fund allows a student organization to submit a request to the Director of Student Governance and Organizations for assistance in funding. A copy of the application form is attached for your information.
2. It is my feeling that it would not be prudent to expand funding to approximately two hundred (200) student organizations in the current financial environment. We are stretched to the limit and our priority should be to maintain quality in our existing programs that are funded by student service fees.

There is no doubt in my mind that many of our student organizations have legitimate funding needs. Let's encourage them to utilize the system that is already available to them. My staff and I will continue to work with them as they attempt to support their members and the University.

## PROGRAM ASSISTANCE APPLICATION

The Student Governance/Organizations Office is available to assist your organization with any and all phases of programming. Registered Student Organizations will be eligible to receive up to \$300.00 per program in assistance monies. In order to apply, please complete this application and return it to the Student Governance/Organizations Office in the University Center. The following four criteria will be used in selecting a program(s):

1. The group sponsoring the program must submit documented evidence of monetary need.
2. The program must have general University-wide appeal and be open to the entire University Community.
3. The program will be considered based on the amount of resources (manpower, time, money) committed by the sponsoring group.
4. The program must have significant potential for enhancing the culture, climate, or educational processes of the University.

Although I am sympathetic with the problems that some student organizations have in struggling to provide services to their members, I recommend that we not approve Student Congress Resolution 92-27. My reasons are as follows:

1. We currently provide program assistance money to student organizations through Student Governance and Organizations. Approximately \$6,000 is budgeted for 1992-93. This fund could be increased as our financial situation improves. The existence of this fund allows a student organization to submit a request to the Director of Student Governance and Organizations for assistance in funding. A copy of the application form is attached for your information.
2. It is my feeling that it would not be prudent to expand funding to approximately two hundred (200) student organizations in the current financial environment. We are stretched to the limit and our priority should be to maintain quality in our existing programs that are funded by student service fees.

There is no doubt in my mind that many of our student organizations have legitimate funding needs. Let's encourage them to utilize the system that is already available to them. My staff and I will continue to work with them as they attempt to support their members and the University.

## PROGRAM ASSISTANCE APPLICATION

The Student Governance/Organizations Office is available to assist your organization with any and all phases of programming. Registered Student Organizations will be eligible to receive up to \$300.00 per program in assistance monies. In order to apply, please complete this application and return it to the Student Governance/Organizations Office in the University Center. The following four criteria will be used in selecting a program(s):

1. The group sponsoring the program must submit documented evidence of monetary need.
2. The program must have general University-wide appeal and be open to the entire University Community.
3. The program will be considered based on the amount of resources (manpower, time, money) committed by the sponsoring group.
4. The program must have significant potential for enhancing the culture, climate, or educational processes of the University.


